WAREHOUSE AUTOMATION SYSTEM GPI INTERNATIONAL DOES NOT STOP ITS DEVELOPMENT IN CHINA

In recent days Gpi (GPI:IM), company listed on the MTA market, leader in IT Systems and Healthcare - Social Services, has signed a new contract with **Suzhou KimAuto Technology Co. Ltd**, supplier with which the Group, in October 2018, has undersigned a distribution agreement for the supply of robotic systems for Healthcare on the Chinese market.

Over the past few years, KimAuto has shown a market excellent ability to develop and penetrate the market: in 2018 for a total value of € 202.000,00 and in 2019 for a value of €967.360,00. Both orders included the supply of grippers and necessary robotic systems for the management of hospital pharmacies in the Shanghai region.

As a Automation, which produces the automation system for the logistics of drug, thus continues its international expansion: the signing of the new order provides for the supply of key components of the robotic systems, **grippers and axes**, for a total value of € 1.054.000,00.

The automated pharmacy system, for the storage and the distribution of drugs, planned both for hospital pharmacies and retail pharmacies, is the flagship of the Company. Its core points are the fact to be completely wireless, the possibility to be gradually implemented thanks to its modular and flexible structure and the high performances, indeed: RIEDL Phasys multipicking gripper moves at 5 m/sec speed, it is the fastest of all competitors. The system is specially designed and tailored to every demand, meeting with space and taste needs and leaving the customer free choice of shape, colour, height and materials used.

This new operation brings the volume of business to China to the value of € 2.223.360,00, once again consolidating our presence in the Country. The growing spread of GPI automation systems abroad is yet another concrete proof of the quality of our technology.
