

# DIGITAL SECURITY OF THE PUBLIC ADMINISTRATION: GPI'S CYBERDEFENCE SERVICES FOR THE EMILIA ROMAGNA REGION

The temporary consortium led with telecommunications operator Fastweb as the lead company and **Gpi Cyberdefence**, a Gpi Group company, among the participants, has been awarded lot 2 of the tender held by the Emilia-Romagna Region's Agency for the Development of Remote Markets for the acquisition of IT system management and IT security services. The total amount of the tender is €40 mln over 36 months. **Gpi Cyberdefence's share is about €2.8 mln and includes the supply of**:

- Vulnerability Assessment and Vulnerability Management: planning, execution and management
  of cybersecurity prevention activities.
- Incident response and Forensics.
- Security Advisoring: development and planning of diagnostic activities and security audits.

This award is an important achievement for Gpi Cyberdefence, which will provide cybersecurity services to a technologically advanced region such as Emilia Romagna — an outcome that consolidates the Group's position as a major partner for the development of digital security systems for public and private organisations. A success in a strategic sector with double-digit growth forecasts, crucial to effective, secure implementation of the public administration's digital transition.
