



GPI SECURES THE CONTRACT FOR THE NEW HEALTH INFORMATION SYSTEM OF SOUTH TYROL € 16 MILLION CONTRACT SIGNED

Trento, 23 January 2025

The Temporary Business Grouping (RTI), steered by Gpi S.p.A., has been awarded the contract to operate, maintain, support, and develop the Health Information System for the Azienda Sanitaria dell'Alto Adige (ASDAA). The contract, with a total value of about €16 million and a term of 48 months, includes a designated €13 million allocation for Gpi.

This Specific Agreement falls under the Consip 'Sanità Digitale 4' (Digital Health 4) Framework Agreement, and aims to develop the Electronic Medical Record (EMR). This involves creating a sophisticated information system that, through the digitalisation of patients' medical data, provides support for clinical and healthcare activities during each phase of care and ensures continuity of care within the same hospital facility. The system will encompass all four health districts within South Tyrol—Bolzano, Brixen, Bruneck, and Meran—catering to a resident population exceeding half a million individuals.

This project is complementary to the existing systems Gpi has supplied to the South Tyrol Health Authority, advancing the digital transformation of hospitals and regional facilities. The initiative will ensure seamless interoperability between information systems and medical devices, placing the medical record at the heart of care processes. Key developments involve implementing Artificial Intelligence for predictive healthcare demand analysis (CUP - Centralized Booking System), and upgrading Telemedicine applications with superior capabilities for both practitioners and patients. Furthermore, cutting-edge tools are included for real-time data management and analysis.

In parallel with the platform's development, Gpi is set to offer maintenance, application management, and support infrastructure, all while ensuring a smooth transition to the cloud to bolster the system's scalability and security. With a focus on cybersecurity, a service-oriented architecture will be integral in safeguarding health information and ensuring the continuity of healthcare data.

Selecting Gpi to establish South Tyrol's new health information system is a testament to the strength and trustworthiness of its solutions, which are currently utilised for handling admissions, e-prescriptions, and medical appointment scheduling. This latest achievement solidifies the partnership between the Group and the ASDAA, continuing the progression of digital transformation through cutting-edge, integrated technologies aimed at optimising care management and increasing operational efficiency.
